# Lead-Safe Training – Available Online

---

There has been a lot of confusion about the new training, work practices and record keeping requirements associated with the EPA Repair, Renovation and Painting (RRP) Rule. When do these regulations take effect. How do I comply? Who has to be trained? Where do I get the training? The new Kansas regulations go effect on April 9, 2010 and training can begin that date.

**Until that time there is NO ONE CERTIFIED to provide this training in the State.**

On a “go-forward” basis however, it is clear that you must be “RRP Certified” and use Lead Safe Work Practices when working in child occupied facilities or homes built before 1978. To become RRP Certified, contractors MUST take a “RRP” Class from an Accredited Training Provider!

Now you can take the necessary training when it’s convenient for you. No sitting in uncomfortable chairs, in stuffy rooms, daydreaming or thinking about what you have to do when you return to work. **No taking time away from your business and no lost income as a result.**

An entity shall make application and be licensed by the Kansas Department of Health and Environment as a Licensed Renovation Firm prior to conducting regulated renovation activities in target housing and child occupied facilities such as remodeling, room additions, window/door removal or replacement, general repair projects, weatherization projects, interior and exterior paint projects, exterior siding installation, or other renovation activity.

**A complete application includes:**

1. A completed *Licensed Renovation Firm Application / Renewal Application* form,
2. Payment for the non-refundable licensure fee as specified in K.A.R. 28-72-3,
3. A list of all KDHE certified employees performing regulated renovation activities,
4. A copy of the firms certificate of good standing with the Kansas Secretary of States Office. (if applicable)
